#### Schedule Summary

Water and sanitary sewer utilities are installed across County A and to the building. Also installed south along County A as far as they can go this fall.

Waupaca County has placed reclaimed sand at Cold Storage Building footprint. Detention pond on west site is dug.



Cold Storage Building was delivered to site .

Sanitary sewer plumbing lines installed in Vehicle Garage, through Administration Area and into Repair Garage.

Repair Garage west end foundations are complete, insulated and backfilled to subgrade.

South and north walls of Repair Garage and Administration Area are being finished poured and backfilled . Break Room foundations are in place.

Sand Storage Shed excavation has started and foundations are to be installed in November.

Electrical conduits below asphalt areas were installed for aggregate base placement.
