CALL TO ORDER AND OPEN MEETING STATEMENT: Shawna Hansen called the meeting to order at 8:35 am and gave the open meeting statement.

INTRODUCTIONS: Everyone introduced themselves. Shawna Hansen is the new Family and Community Services Manager.

STAFF CHANGES: We are in the process of hiring one fulltime and one half time CST positions.

ENROLLMENT UPDATES: Nineteen clients are enrolled as of January 1, 2019. Six youth are on the waiting list. The average length of stay in the program is 715 days or approximately two years. The wait list is prioritized by client needs. Laurie Schmidt asked for a breakdown of enrollment by community for future meetings. Shawna shared the story of a client who has been in the CST Program and successfully graduated. Jan and Shawna meet each week to review the CST/CCS referrals.

PRESENTATION BY PARKS AND REC DEPARTMENT: Laurie Schmidt handed out an information sheet she put together with Park and Rec information for seven different cities in Waupaca County. Laurie Schmidt introduced Andrew Whitman from the Waupaca Parks and Rec Department. Andrew handed out and reviewed the Waupaca Activity Guide. The program focus is on family activities. Non-resident fees is an issue that Andrew is working on. Jill indicated it is hard for foster families to afford the fees. Shawna suggested asking for private donations or scholarships to help with program costs. Big Brothers and Big Sisters is active in the Waupaca area. They can meet at the Rec Center. Thank you to Laurie for coordinating this presentation.
