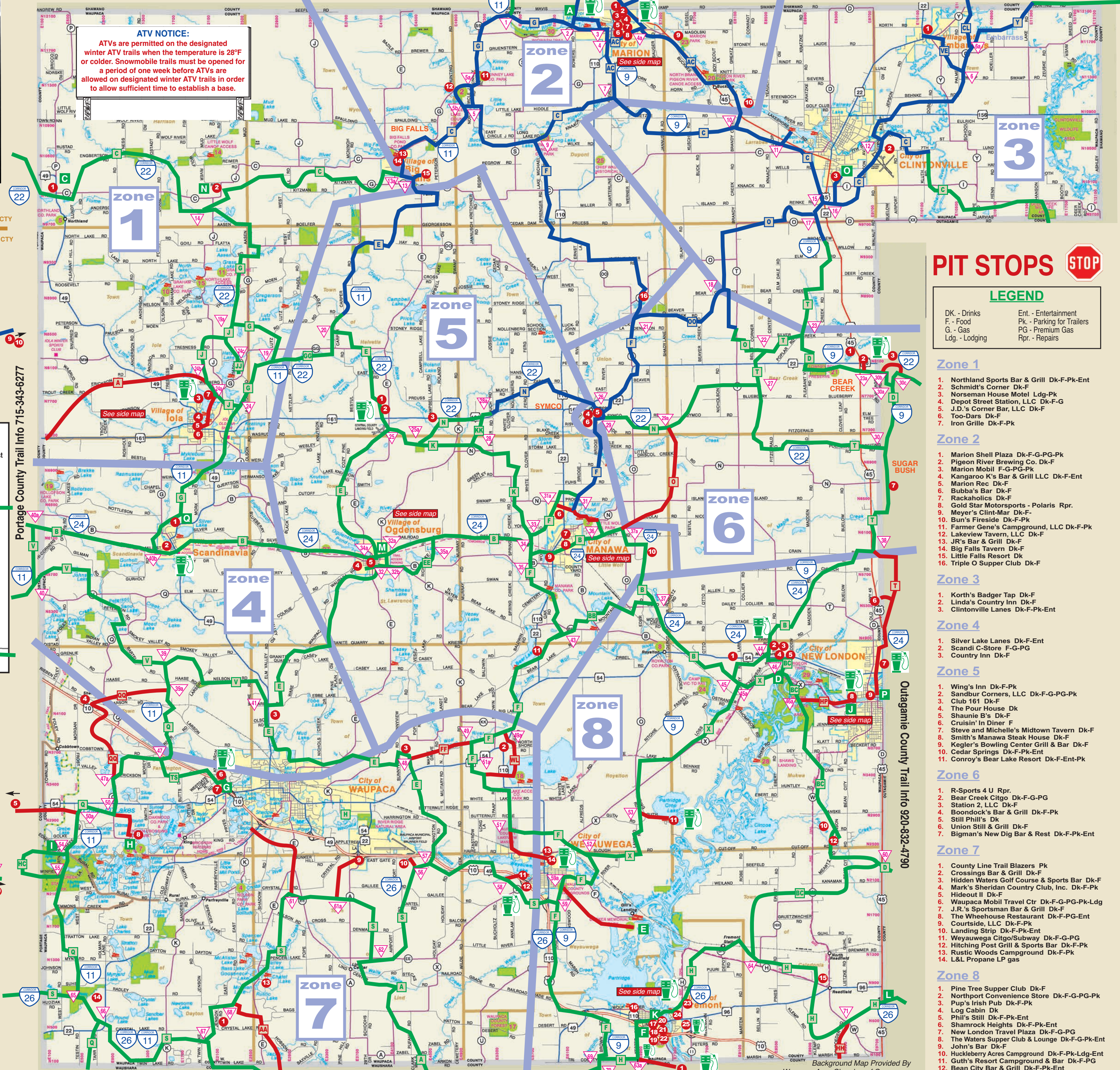


Marathon County Trail Info 888-575-7669



ATV NOTICE: ATVs are permitted on the designated winter ATV trails when the temperature is 28°F or colder. Snowmobile trails must be opened for a period of one week before ATVs are allowed on designated winter ATV trails in order to allow sufficient time to establish a base.

To access from the Tomorrow River Trail use Intersection 32a, go south to Intersection 32b, then west to intersection 32, then turn north to dead end at bars. Do not use non-designated city streets, please stay on marked trail!

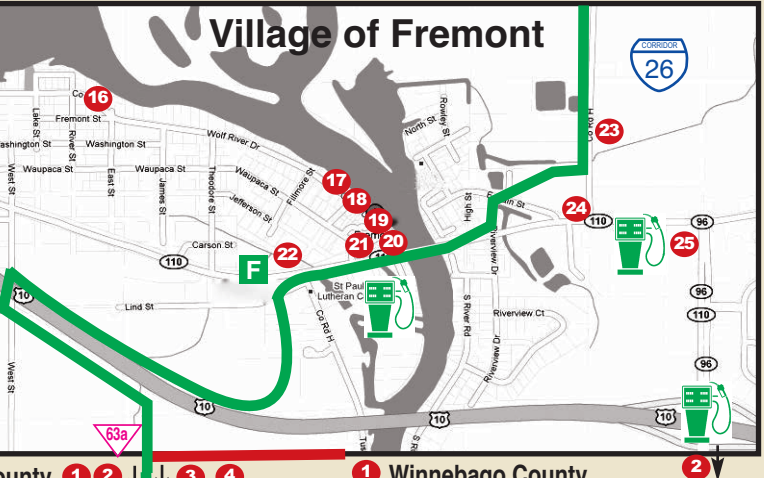
