1. PROJECT OVERVIEW

The Waupaca County Sheriff's Office is soliciting bids from qualified vendors to acquire and install an interior 14' x 14' overhead electric door at our Evidence Garage located in Manawa, WI.

2. PROJECT SCOPE AND SPECIFICATIONS

The Sheriff's Office Evidence Garage Overhead Door and Install project involves cutting a 14' x 14' opening in a concrete interior wall, supplying and installing an interior electric overhead door. This door will separate the cold storage area from the heated storage area.

The overhead door and install project should meet the following minimum specifications:

- a. Cut 14' x 14' overhead door opening
- b. Reinforce block wall per State Code
- c. Remove electrical
- d. Removal and cleanup of construction debris
- e. 14' x 14' 3 hour rated coiling fire door w/operator
- f. Electric safety edge
- g. 2 three button stations
- h. 2 smoke detectors installed
- i. Project work must meet State Code
- j. Bidder must be a Certified Metallic Builder

Waupaca County will provide electrical work necessary to complete this project.

3. QUESTIONS

Any questions pertaining to this bid should submitted in writing and sent to the contact listed in Section 10 of this document. Bids must be received prior to the 'Questions Due' date and time listed on the bid cover sheet. Any correspondence or questions submitted must include the bid name and number.

Responses to questions will be posted on the County website <u>http://www.co.waupaca.wi.us/businesses/bids_and_proposals.php</u>. Bidders are responsible for checking the website for any addenda prior to submitting a bid.

4. CLEAN-UP

After all wall removal and door installation is complete, vendor will make sure any scrap, extra materials, and tools have been removed from the site.

5. PROJECT SCHEDULE

The expected project completion date is on or before June 15, 2019. If this date needs to be adjusted, please include your proposed date, as well as your reasoning for shifting the schedule. All proposed date changes will be considered.

6. PROPOSAL REQUIREMENTS

All bids must be received by the due date and time listed on the bid cover sheet in order to be considered. All bids shall contain the following items:

7. PROPOSAL SUBMISSION

Bidders must submit three (3) copies of complete bid, including all required materials for acceptance of their bid by the due date and time listed on the bid cover sheet. All bids received after that date and time will be rejected.

9. CRITERIA FOR SELECTION

The following will be considered to evaluate proposals received:

- 1. Quality and content of company's written proposal
- 2. Company's history and experience with similar projects
- 3. Company's proposed lump-sum fee to complete this project

All prices, costs and conditions outlined in the bid shall remain fixed and valid for acceptance for a minimum of ninety (90) calendar days starting on the due date for this bid.
