Bids for each truck will be received in sealed envelopes plainly marked "Waupaca County Parks Truck Bid", or "Waupaca County Solid Waste Truck Bid" in the office of the Parks and Solid Waste Department, 811 Harding St., Waupaca, Wisconsin 54981, until **9:00 a.m. local time on the 6th day of April, 2017.**

Waupaca County reserves the right to reject any or all bids, waive irregularities, or accept the bid most advantageous to the County of Waupaca. The successful bids will be awarded by the respective Committee/Board on the basis of which bid best fits the requirements of Waupaca County.

INSTRUCTIONS

To better facilitate bids from the various suppliers, we have provided you with general specifications. If the items listed in our general specifications are not standard on your product, please include them in your total bid. Do not add said items as accessories. It is our intention to list only those specifications which meet our minimum requirements. If your product does not meet the specifications, quote as close to them as possible and note the variance. Our decision will not be based on these exact specifications alone. A brochure showing as many pictures as possible of your truck must be provided.

Waupaca County Solid Waste Specifications

¾ Ton Extended Cab Pickup Truck

Engine – 6.0 Liter or more, gas, with high capacity air filter and heavy duty alternator

Transmission – Heavy Duty automatic, tow/haul mode and auxiliary cooler

Four Wheel Drive – Shift on the fly with automatic hubs

G.V.W. – 9,200 lbs minimum

Tires – All season E-rated or equal. Spare rim and tire to match.

Rear Axle – With locking differential

Power Steering

Brakes – Power ABS traction control

Trailer Tow Package – With electric brake control and a class three hitch

Cab – Extended Cab, cruise control, heater, air conditioning, AM/FM radio, Bluetooth, intermittent wipers, gauges, courtesy lamp ceiling mounted, power windows, split bench front seat with heavy duty vinyl upholstery, fold down center arm rest, electric adjustable extendable towing mirrors, sliding rear window, back-up camera and monitor.

Color – Preference is Silver

Rust Proofing – 5-year warranty, unlimited miles

Warranty – Describe

Truck Box – 8' box – no bed liner, just painted (need to be able to slide pallets in and out. A topper will be mounted to this truck at a later date (not included in this bid). Truck must have a back up alarm.

Additional Lighting – Low profile, 360 degree LED light bar on cab, one pair of alternating LED flashers in front grill, and one pair of alternating LED flashers on rear of the vehicle. All wired to a hot switch on the dash to allow use with the key off.
